You are usually the tour guide for a trip to the Sixth Floor Museum, either the AT&T Stadium or the American Airlines Center for a game, the Dallas Heritage Village at Old City Park, or a nice dinner and tour at the Geo-Deck at Reunion Tower. Then off to our wonderful George W. Bush Presidential Center tour and a visit of the SMU campus while you are there. Maybe you will even get a chance to visit the Klyde Warren Park with a stop at the Dallas World Aquarium. Or maybe they want a little shopping so off to NorthPark Center or Galleria for a fun day. Or back downtown for a little history and a visit to the Old Red Museum and then stop for some pictures at Pioneer Plaza. Or of course, you can't miss a trip out to Southfork.

But, we still have hundreds, yes hundreds of other great places we can take them. From our wonderful museums, parks and landmarks to our many, many different restaurants. So, here are more to add to your list. I figure if we take every day of the year, there is absolutely no way we could visit or enjoy every restaurant, venue, see every play, concert, sporting or cultural event that our area has to offer. But it sure is fun trying. So enjoy!

Fair Park and The Hall of State





This wonderful building was built for the Texas Exposition and a great homage to Texas. The building tells the story of Texas history from vast spaces to the Texas Revolution.

It is a great venue for events and always has a special display and a "must see" during the State Fair of Texas.

While you are there explore all the other buildings in Fair Park -- the largest collection of Exposition Art Deco buildings in the world, the Dallas Children's Aquarium with sharks and even sting rays that you can touch. And the Discovery Garden with an indoor butterfly exhibit with butterflies from all over the world, and don't forget the African-American Museum.

Dallas Arboretum and Botanical Gardens



Here is a little history about how it all started.

In 1974, the Dallas Arboretum & Botanical Society (DABS) adopted bylaws, elected officers and incorporated as a nonprofit organization.

In 1977, the City of Dallas Park Board recommended that the grounds of the DeGolyer Estate, which the city purchased from Southern Methodist

University, be the official location of the botanical garden. The city encouraged DABS to raise funds for the initial costs.

• During 1978 and 1979, DABS membership and awareness increased. Both business and local citizens began to support the Arboretum project.



- By 1980, DABS had raised over one million dollars and purchased the 22-acre Alex Camp House, which is adjacent to the DeGolyer Estate. Both houses are located on White Rock Lake.
- In 1982, the City of Dallas and DABS signed a contract creating an arboretum and botanical garden on the combined 66 acres of the DeGolyer and Camp properties. The gardens opened to the public for the first time in 1984.

Now you can enjoy endless events, the many beautiful gardens, programs, café and tea service, concerts and the latest attraction of the Children's Adventure Garden.

The Freedman's Cemetery



Freedman's Cemetery, as the name suggests, belonged to a community of former slaves established in this area after the Civil War. Dedicated in 1869, the cemetery closed in the 1920s and suffered from both neglect and vandalism. In the 1930s-40s, the construction of an expressway and a major intersection eliminated most of the remaining above-ground reminders of the cemetery. In the late 1980s, efforts to expand the city's Central Expressway led members of the local community, including descendants of

those buried in the cemetery, to wage a successful campaign to halt freeway construction long enough for an archeological survey and excavations of the cemetery and the relocation of those interred within it. Between 1991-94, an archeological investigation uncovered more than 1,000 graves, which were carefully relocated, and the local community constructed this memorial. I am sure you have passed it many times on your trips up and down Central Expressway, so one day just stop for a quick visit. It is free admission. It opened in 1999 with an arched memorial and sculptures by David Newton telling the story of African Americans and their descendants' journey from slavery to emancipation. Poems around the perimeter also commemorate those originally buried here. (2700 Lemmon Avenue, Southwest corner of North Central Expressway)

Dallas Zoo

The history of our Zoo:



- The zoo was established in 1888 with a purchase of two deer and two mountain lions for \$60 and placed in pens on display in City Park.
- In the 1890s, the Dallas City Council approved funding for the zoo and more animals were purchased and added to the zoo's collection until 1910 when it moved to Fair Park.
- In 1912, the zoo moved to 36 acres in Marsalis Park which the city had purchased in 1909, from which it has expanded to its current size.
- In the 1920s, a special Zoo Commission was created by the city and the collection was further developed with the acquisition of numerous specimens from game hunter and trapper Frank Buck.
- In the Depression Era of the 1930s, the facilities at the zoo underwent extensive renovation funded by the Works Progress Administration.
- The Dallas Zoological Society was established in 1955 to support the zoo.
- By the 1960s, the zoo was a popular and profitable attraction.
- In 1966, the zoo displayed over five hundred species of animals.
- By the 1980s, attitudes began to change from the profit driven display of animals toward science and the humane treatment of animals strongly advocated by the AZA. More emphasis was put on saving endangered species and breeding animals in captivity. The Dallas Zoo cooperated with this program and was accredited in 1985.
- Two bond measures, amounting to \$30.4 million, brought the expansion from the drawing board in 1983 to its opening in June 1990

- On June 14, 1996, rail and bus service arrived at the zoo. Dallas Zoo station opened on the first phase of the Red Line. The connection to DART made getting to the zoo significantly more convenient than ever before.
- In 1997, the 19,000-square-foot Kimberly-Clark Chimpanzee Forest exhibit opened to the public.
- On May 8, 1999, the 2-acre \$4.5 million ExxonMobil Endangered Tiger Habitat opened.
- On September 3, 2008, the zoo announced it had received the largest gift in its 120-year history, a \$5 million donation from Harold Simmons. This donation, as well as other factors, allowed the zoo to fast track the construction of the Giants of the Savanna habitat.
- On August 12, 2009, the Dallas City Council voted unanimously to turn the zoo over to private management. On October 1, 2009, the zoo's management responsibilities, animals, and employees were officially turned over to the Dallas Zoological Society.
- On May 28, 2010, the Giants of the Savanna habitat opened to national acclaim.
- On April 1, 2015, the Dinosaur exhibit opened hosting over 20 animatronic dinosaurs.

So hop on DART and visit the Dallas Zoo. Great for family, events, meetings, that special birthday party or just a day of fun.
