

Adele's debut album, 19, was released in 2008 to commercial and critical success. It is certified seven times platinum in the UK, and double platinum in the US. On 18 December 2015, her sales were estimated at more than 100 million combined singles and albums, making her one of the world's best-selling artists.

To mark Mrs. Reagan's passing, Dale was asked to write an op-ed column which appeared in the *Dallas Morning News* that celebrates her "remarkable life well lived." It's a touching tribute from Dale's unique perspective as someone who spent a lot of time with the Reagans - both inside and outside of the White House.

# Dale Petroskey: The Nancy Reagan I knew

As I head to California for Friday's private funeral service to honor Nancy Reagan, the memories keep flooding back; I haven't been able to get her off my mind. She and President Reagan have had that kind of impact on me these past 30 years.

In April 1985, I was invited to serve as assistant White House press secretary to President Reagan, just months after he had won 49 states in the largest re-election landslide in American history.

In my role, I saw the president nearly every day, as did other White House staffers. But never did I dream I would share time with the Reagans in less public moments, during their down time, away from





The White House. In March 1986, Press Secretary Larry Speakes assigned me to accompany the Reagans to Camp David, the presidential retreat in Maryland, for weekend duty. That first Camp David weekend turned into 10 weekends, and that is where I began to understand the essence of these two remarkable people, Ronald and Nancy Reagan.

The president would often say, "My life began the day I met Nancy," and it was obvious she felt the same. What I saw up close was the absolute love between

them, this couple burdened with the world's greatest political responsibilities. It was the way they cuddled on the sofa as we watched movies in their Camp David living room. It was how they talked to each other, how she reached for his hand as they walked, how they enjoyed those afternoon rides on



horseback through the woods — just the two of them. When they were together, they were happiest; it was as if all those great responsibilities were far, far away.

Nearly 20 years after the Reagans had left The White House, and four years after the president's passing, I was in Los Angeles. It was January 2008, and I called Mrs. Reagan's office, wondering if it might be possible to stop by and say hello. I quickly received a call back from Joanne Hildebrand, her longtime trusted aide; she said Mrs. Reagan would be happy to see me at her home.



I arrived expecting to say hello, see how she was doing, exchange a few pleasantries, and be on my way. I figured I'd be there 15 minutes.

Mrs. Reagan, ever gracious, greeted me at the door, and took me on a tour of her Bel Air home. It sat high above Los Angeles, with a panoramic view of the ocean, mountains and city skyline. She walked me out to the backyard, and explained that that breathtaking view is why President Reagan loved this home, and why he wanted them to live there. For her, it was always about him.

After the tour, we settled in her living room where she served lemon cookies and tea, and we talked for an hour and a half.

We talked about the old days, remembering special moments during the presidency. We talked about people who worked in the White House; she asked who I stayed in touch with. We talked about the upcoming 2008 election, which was in early primary season. I was impressed by how closely she followed the politics of the day. We talked about stem cell research, which she became passionate about during President Reagan's battle with Alzheimer's Disease.

I asked if she had been traveling. She said, "No, I don't like to travel anymore. When I'm here at



home, Ronnie is everywhere. I feel him everywhere. When I travel, it's lonely and an empty feeling. I can't wait to get home again to this place we shared and loved."

While there will be sadness at the Reagan Presidential Library on Friday, we also will celebrate a remarkable life well-lived. And it will be comforting to know that Mrs. Reagan and her Ronnie will be sideby-side again, where they have always been happiest.

Rose Futterknecht received a total of 20 applicants. Completed applications have been sent to the judges and the judging process will be completed by March 28<sup>th</sup>. At that time the finalists will be determined and interviews will be scheduled. (ASIST): The final day of submission for the ASIST scholarships is March 31<sup>st</sup>. As of today, we have had two applicants.
