Elevate your experience as you serve EWI. Send your Chapter President a note of thanks after an EWI meeting expressing thanks to her for facilitating the event. A lot goes into the planning for a meeting. She has worked with the Program Chair, Sergeant at Arms, Recruitment/Retention Chairs, and Communications Chair to provide a meeting for her Chapter that serves one of our tenets – Connections, Careers, Community. Most likely, she has sacrificed some time with family making phone calls and creating email messages to make this meeting happen each month.

Be a mentor to a new member. Teach her **everything** you know about EWI. Give her the **experience** you had when you joined your Chapter. Acquaint her with every member and help her feel comfortable at meetings. Don't for a minute think she will find her way on her own. Give her a phone call and check in on her, making sure she knows when the next meeting is scheduled. Ask her what she hopes to gain from the organization. Does your Chapter have a Lunch Bunch? Make sure she knows when those are planned. That is a great way to get to know each other outside of a Chapter meeting.

Get **engaged** on the website. We have this great communication tool, and you can find documents to help you in your board or committee role. You can connect with 1,000 or more representatives. There is an all-member group where you can ask a question or share photos if you like. Update your profile and include the kind of business your firm represents. Keep it simple and make it easy for EWI sisters to find you and then connect with you.

**Explore** the Operating Guides when your Chapter has a question. Most if not all the answers you seek are there and if you cannot find them in the guides, check the Bylaws. These documents can be found on the website. It's a good idea to download them on your phone/desktop or print them if you can. That way you will have them within reach during your Chapter/Board meetings.

Have **empathy** by accepting people for who they are and make your board your priority. We must check in on each other and make sure everyone knows what they need to do each month. Invest some time in developing a good relationship with them. The Board will be stronger when they see that everyone cares about what they are doing. The rest of the membership will see it too.

Be a Chapter of Excellence. How exciting it was to be on the team who chose the Chapters of Excellence last year. It was such a pleasure to award five Chapters with this honor during the last LCAM. Did you know that Chapters start working toward this goal right after LCAM? We as a Board would sit in the back of the room while all the Chapters took their tables in the front. We want to celebrate you at LCAM 2022!


















Member Jeannette Davis, JLL, was the winner of our
