


Happy March!

What a difference a year or two makes! From winter storms to COVID, 2022 is shaping up to bring us back to a sense of normal. As we settle back into some type of "normal" I LOVE the opportunity to see everyone in PERSON at meetings! I understand that the virtual meeting works for some; I am just thankful we have the opportunity to meet in person again.

March is Women's History Month and EWI of Dallas helps to celebrate by amplifying women's voices and celebrating female leadership. The EWI experience is based around our three core tenets: *connections, careers, and communities*. The value of each to our member firms and representatives is as diverse as our members themselves.

I have been lucky enough to work with several phenomenal women in the DFW area during my career. I worked with Premier Designs Jewelry, and the founder, Joan Horner. In 1975, Joan joined her husband, Andy, at Home Interiors and Gifts, where she became a close companion and associate to pioneering Dallas businesswoman Mary Crowley. After years of prayer and world travel to research mission possibilities, the couple founded Premier Designs in December 1985.

The Horner's built the business on Biblical principles and dedicated it to serving people and supporting ministries worldwide. In 25 years as Premier's executive vice president, Joan, became known as beloved "Queen Mother," inspiring and enriching countless lives through her personal touch. She was legendary for her handwritten notes to offer encouragement and thanks and prayer. Aptly, her favorite sayings were "**Keep it personal**" and "**Count it all joy.**"



I was then lucky enough to land at the Ebby Halliday Corporate Offices and had the privilege of hearing many great stories of how Ebby built her empire in real estate as a female. Ebby had a vision the size of Texas. She believed that above all else, you must "Improve your life by improving the lives of those around you." From the beginning, Ebby had a knack for sales. She launched her North Texas career in 1938 selling hats. What made her so good at it was that she understood intuitively that buyers make decisions based on emotions rather than rational thought. When she entered real estate, she applied that wisdom to selling houses. In the first homes she sold, she put up drapes to showcase the windows, laid down carpet on the floor, added furniture, and had the yards landscaped. She made it feel warm, enticing, inviting. She made it feel real. "Buyers have no idea what they want until they see it," Ebby said. "We have to give them a picture. Our job is to give them a better idea what the house will look like after they move in."

By 1958, Ebby Halliday, REALTORS had sales of approximately \$12 million, an impressive number, given the median home price at the time was around \$24,000. For over 75 years, her company has been built on three principles: service to the client, service to the industry and service to the community. I keep her saying that she would tell people on display by my computer so I can see it every day, "**Do something for someone every day.**" Ebby was also big on handwritten "thank you" notes, and to this day, I still send out handwritten notes.


What incredible women they were and what beautiful legacies they leave behind **about keeping it personal, counting it all joy and doing for others.**
